Mayor Rigg called the Regular meeting of the City Council of Jefferson, South Dakota, to order. Motion to approve the agenda by Lokhorst second by Stokely. Motion carried. Motion to approve the minutes of the March 4, 2024, City Council meeting by Boulware second by Lokhorst. Motion carried. Motion to approve the minutes of the March 19, 2024, Boards of Equalization meeting by Boulware second by Lokhorst. Motion carried.

#### **UNFINISHED BUSINESS:**

The former JHS property was first on the agenda. Mr. Tom Johnson was present to discuss the progress made at the former JHS building and to share a report from RISE Structural Associates, Inc. regarding the gymnasium building. Chris Hamilton, PE, Structural Engineer has determined the existing structure can accommodate new wood roof trusses. A discussion followed. Mr. Johnson mentioned his plans for the property. CA LaFleur-Sayler stated the current contract calls for red-tagged structures to be removed by July 15, 2024. The City Council may amend that order but that has to be done formally upon the advice of their Building Inspector Gary Roan. Motion by Stokely to table the matter until May 6, 2024, City Council meeting after BI Roan has met with Chris Hamilton, Tom Johnson, and Curt Johnson to advise the City Council as to the soundness of this plan second by Lokhorst. Motion carried.

The Union County Pre-Disaster Mitigation meeting was held March 27, 2024, in Elk Point. The PDM committee needed a Capability Assessment which was forwarded to FO Roark to be completed.

The FO informed the City Council the Union County Assessor has agreed with their action taken during the Local Boards of Equalization.

CA LaFleur-Sayler discussed 607 Wilson Street with BI Roan. After reviewing the information, a first-class letter and a certified letter was sent to the property owner concerning the dilapidated condition of the garage on the property. The letter was delivered April 1, 2024.

PC Sharkey asked the City Council about contributing to the purchase of one of the thermal cameras the Jefferson Fire Department was purchasing. PC Sharkey would like to have access to the camera should he need it while working as PC. A discussion followed. FC/CM Stokely said he would have to discuss this with the Firemen at their April 15, 2024, meeting as the original agreement amongst the firemen was the camera was not to leave the building except for official business.

#### Street Department:

Repaint street lines and stop lines. Quote from Dakota Traffic Services \$1,893.60.

Motion to paint the lines on the streets and stop lines by Boulware second by Lokhorst. Motion carried.

Still need to get together with Council on Street for Chip Seal or repair. Chip Sealing is \$5,960.00 a mile.

Complaint about a bump on the roadway near 100 Main Street. Bump is in asphalt; I called the County Highway department and informed them of the complaint.

Fire Hydrant at Main Street and 3<sup>rd</sup> Street not working. Johan Sundheim was called for repair.

### Water/Wastewater Department:

Normal operation and everything working as it should.

Basic Water Treatment class, failed test. Will retake on May 9, 2024.

Water Distribution class, 4/16-4/18 in Mitchell.

The 2023 Water Quality report is available at City Hall and was published in the Leader Courier March 28, 2024.

#### Parks Department:

Mowers have been serviced and ready for the year.

Quote from Cardis Fence for the softball field backstop, \$2,875.00.

Motion by Boulware to get the backstop installed on the softball field second by Lokhorst. Motion carried.

AJ Boulware asked about a batting cage location as he is purchasing one.

A discussion followed about setting it along the fence behind the water plant.

CM LaFleur advised the City Council of the discovery of Ash Bore Beetles in a tree on North 3<sup>rd</sup> Street.

PC Sharkey noted DANR sent the City Certificates of Achievement in 2023 for the city's public water system and Operator Randy Crum.

Mayor Rigg recognized Nicole Werner and Annabel Dirksen. Ms. Werner addressed the City Council about a planned Blues, Brews and BBQ event planned at Jefferson Beer Supply on May 25, 2024. Ms. Werner asked if it would be permissible to put the events tent in the park. The event will be held from 1:00 p.m. to 6:00 p.m. Ms. Werner advised she asked the adjacent neighbors and received no objections. CM LaFleur asked Ms. Werner about where he would direct any complaints about the music/noise. PC Sharkey stated he would take care of any complaints. Motion by Boulware to allow the tent to be set up in the park for the event second by Stokely. Motion carried.

Ms. Werner also stated they have scheduled a Food Truck battle April 27, 2024, that will be located on their property. CM Boulware asked about brewery customers parking on City property and people leaving the park. Should someone get hurt who is responsible? PC Sharkey stated the vehicle owner at fault would be liable.

#### **Informational Items:**

CM/FC Stokely advised the City Council about an expense the Fire Department is facing. The Fire Department received a grant to help replace some of their outdated gear for firefighters plus they have the opportunity to purchase a machine that is utilized for filling SCBA's for \$7,000.00. A discussion followed. FC/CM Stokely asked if the city could help the Fire Department financially when it comes to purchasing these items. A discussion followed and FC/CM Stokely will have more information at a later date.

Reminder: Spring Clean-Up Day for area residents April 19 through the 21<sup>st</sup> with dumpsters located in the city parking lot by the park.

A letter from the Family of Sue Lulf was received concerning the Sue Lulf Memorial Walk/Run for 2024. This year there are levels of sponsorship, and the list was discussed. Motion by Lokhorst to choose the Platinum (\$300.00) level of sponsorship second by Boulware. Motion carried.

Special meeting 4-16-2024: Canvassing the pollbooks.

Days of '59 fundraiser Movie in the Park scheduled for May 22, 2024. Motion by Boulware to donate \$300.00 towards the cost of showing the movie on the Mega Screen second by LaFleur. Motion carried.

The City Council was given the new South Dakota tourism maps, and the City of Jefferson is on the new map.
